## **A. Educational Qualification.**

- (1) Must have passed 10 + 2 examination.
- (2) Diploma holder equivalent to 10 + 2 are eligible.

## **B. Age Limit**

The candidate must have completed 18 as on 01.07.2016 based on HSC certificate thus the lower age is 18 years and upper age limit is 40 years as on 31.07.2016.

**C. Residential Criteria.**

1. Candidates should be staying to the concerned Gram Panchayat in which he/ she is applying for.
2. Residential Certificate issued by Tahasildar/ Additional Tahasildar Issued within 6 months from the date of application shall only be considered. The candidates must enclose attested copies of the certificates, mark sheets in support of their eligibility as indicated at A, B, C. Absence of any of the copy of the required document/testimonials shall be liable for rejection of application without any further communication.

**Selection Criteria**

1. Strictly based on the Marks obtained in 10+2 Examination. Marks obtained in Extra Optional shall not be taken in to account.
2. Preference will be given to candidates having Commerce Stream, Computer Proficiency of 'O' level with use of Oriya language in Computer.
3. The Selection of Gram Rozgar Sevak will be done at DRDA, Sambalpur by District Level Selection Committee and a panel of the selected candidates shall be prepared. Engagement on contractual basis shall be made by the respective Gram Panchayat and Agreement indicating the terms and conditions shall be executed by the concerned Sarpanch in the Non- Judicial Stamp Paper.
